# **Updates of the Profit and Loss by Caroline Gibson**

- Restarted the new P & L as the budget for NY was approved.
- We have more money in PayPal, but it has not been transferred to iBooks. There are some restrictions, and they will figure out how to move it to QB
- 131 Resident members overdue for HOA dues
- 28 more than 1 year past due
- Caroline gets more stamps to send paper statements to Residents to pay their dues.
- 131 Residents will receive mail, allowing them to pay the dues. They are subject to a \$10 late fee. If the homeowner takes no action, the lawyer will be involved.
- 2 payments are mailed and received.
- Everything is all caught up in P& L for July 2024
- The statement will be sent first. At the August meeting, Caroline will present the Residents who have not paid the dues, and a lawyer will be involved with those Residents who have excessive HOA past dues.
- Caroline renewed the P.O. Box and paid utilities and maintenance expenses outside the dues.
- We are paid for mowing for the year.

- Steve will compile the list of all violations.
- Steve will send the mail via regular mail. Caroline will take a photo to and Steve will track it.
- Architectural Committee asking them to come occasionally to the HOA meeting.
- If any renovations are taking place, the residents/homeowners will need to fill out a form and submit it to them.
- The architectural committee creates a streamlined process to ensure that all homeowners abide by it. This ensures that the HOA has a paper trail of all renovations.
