Letter from our President

Hello neighbors, we hope you all had a great holiday season and everyone is getting ready for spring.

In December, the neighborhood was beautifully lit and Santa and his carriage made its way through the Huntington Hills successfully. We hope you all enjoyed the event.

PARK UPDATES: The HH park is getting a facelift and some updated equipment. The front basketball court has been resurfaced and painted with children's games, while the front basketball hoops were removed as they were damaged beyond repair and unsafe. We are looking to get the back basketball court resurfaced, then painted with both basketball and pickleball lines. At this time the intent is to keep the basketball hoops there and pickleball players can bring their own nets. Four new regular swings and two new smaller children swings have been installed and new paint is ready for use. The main playground structure has new paint, but our painter will be out in the spring to touch up in some places. A new volleyball net will be installed in the spring. Over the last few years there has been a drainage issue making the grassy area between the pool, volleyball court, and creek very soggy. This will be fixed this spring as we've contracted a company to repair the area professionally. There's been the idea to have a "Grand Re-Opening" of the park, if you have ideas or want to volunteer your time, please let a trustee know.

This spring/summer we'll have two trustee positions up for election, please reach out if you are interested in becoming a candidate. The trustees work hard for the free kudos and criticism they get, but it's part of the position and gives you a sense of service to the wonderful neighborhood we live in.

Finally, I remind you to vote and submit your proxy ballot. There will be another SPECIAL MEETING, on Tuesday, June 13th at 6:30pm. I understand there is some confusion as to why we extended the voting window. We intend to put each issue to rest so we can settle these topics for good. We are executing the vote per the Bylaws and Declaration set by the Association. We are happy to answer questions you may have at any of the monthly meetings. I highly encourage you to attend and we plan to host them down at the park again once the weather allows.

Dues


Annual Dues statements were mailed to residents at the beginning of March.
