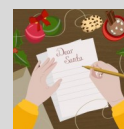
I look forward to the beautiful holiday lights throughout the neighborhood and hope each and every one of you enjoy the next few months.

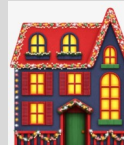

Holidays in Huntington Hills

Letters to Santa: Letters to Santa will be answered this year! Please place your child's letter to Santa in one of the Santa Mailboxes. Mailboxes will be located on both sides of Huntington Way, one near Refugee Road and the other close to Forest Lane Avenue. Deadline for letters is Saturday, December 17 at NOON. *Parents* - Please make sure that your child's name and address appear *clearly* in the letter.

Holiday Lights Contest: Ballots with your three favorite displays may also be placed in the Santa Mailboxes. First, Second and Honorable Mention winners will be selected based on votes received. Deadline for ballots is at NOON on Saturday, December 17. Printable ballots will be posted on the HHCA Facebook page. Paper copies will be available in the Holler Newsletter stands. Focus on the HHCA Code of Regulations by Lisa Stoklosa

Did You Know?

Commercial vehicles, campers, boats, trailers and other recreational vehicles may not be parked outside your garage for more than 72 hours.

Article X1, item #24 states:

"No commercial vehicles, camper, boat, vacation vehicle, trailer, motorcycle, snow mobile, construction or like equipment, or mobile or stationary trailers of any kind, shall be permitted on any lot of the subdivision unless kept in a garage and completely enclosed. This restriction does not prohibit, however, the parking for an intermittent period not to exceed seventy-two (72) hours in any given month, for the purposes of loading, cleaning, or repairing such vehicle or boat."
